Dear Director Soura,

First Choice VIP Care Plus by Select Health of South Carolina wholeheartedly supports the Healthy Connections Prime program and strongly encourages the Department to submit a letter of intent to CMS for a two year extension of South Carolina's integrated care dual eligible demonstration in response to the July 23, 2015 memorandum from the CMS Medicare-Medicaid Coordination office (MMCO).

As one of the Department's four Coordinated and Integrated Care Organization (CICO) partners, our organization has demonstrated and remains committed to this integrated delivery system and payment model aimed at improving the quality, coordination, and cost-effectiveness of services for dual eligible individuals. Aside from the unforeseen program delays, the collective investments, hard work and collaboration by the Department, CICOs and other stakeholders have already shown great promise, and after only 5 short months since the February 1, 2015 Prime implementation, that this model of care can and will improve health outcomes, quality and reduce the cost of care for this fragile, underserved and complex dual eligible population here in South Carolina. Our work has just begun.

We see the State's option to extend the demonstration a real opportunity for the Department, CMS and CICOs to collect sufficient quantitative and qualitative data needed to evaluate and validate overall program effectiveness. We also support MMCO's belief that this change in end date will minimize the risk of beneficiary disruption and supports clearer decision-making in state budgeting while evaluators collect and analyze beneficiary outcome data.

Lastly, we acknowledge that the challenges and opportunities to improve access, quality and cost of care for the some of South Carolina's most complex and chronically ill individuals has not been without its difficulties. These were mostly expected as with any huge transformation. Rest assured, First Choice VIP Care Plus is ready to move forward with the Department, CMS





and other stakeholders towards the work at hand and to demonstrate over time that Prime achieves its intended program outcomes.

Dear Christian,

Absolute Total Care, AdviCare Advocate, First Choice VIP Care Plus and Molina Dual Options, the four health plans participating in Healthy Connections Prime ("Plans"), strongly encourage the Department to petition CMS for a two year extension of South Carolina's dual eligible demonstration project in response to Tim Engelhardt's memorandum of July 16, 2015.

Over the last four years, the State, CMS and the Plans have invested tremendously and collaborated extensively to develop a more efficient and effective system for serving South Carolina's dually eligible population. The Plans have and continue to allocate substantial resources toward provider network development, technology infrastructure and management expertise for this population. Unfortunately, this effort's complexities inevitably created delays, mostly around enrollment, leaving insufficient time to accurately test the demonstration.

Not extending the demonstration would prevent collection of data incorporating statistically sufficient enrollment to evaluate Prime's effectiveness. Prime will result in both better care for the State's most vulnerable and savings to the State's Medicaid budget, but the effort will be lost if we do not allocate sufficient time for the demonstration. We urge the Department to continue its work supporting Prime and preparing for passive enrollment.

Historically, health services for this vulnerable population have been disjointed, resulting in poorer health and often earlier-than-necessary transitions to institutional care. Developing true management of this population has not been quick or easy, but the Plans remain committed to Prime's purpose and success.
