

Measure Release Notes to Clinician Performance Information on the Compare Tool on Medicare.gov CY 2023 Clinicians Public Reporting

August 2025

Overview

CMS has updated its analyses of the calendar year (CY) 2023 Quality Payment Program (QPP) performance measure data that were previously approved for public reporting. Additional Merit-based Incentive Payment System (MIPS) and Qualified Clinical Data Registry (QCDR) quality measures are now available for clinicians and groups to review and to be included for clinicians and groups on the Medicare.gov [compare tool](#) through profile pages and in the [Provider Data Catalog \(PDC\)](#).

For multiple performance rate measures that meet public reporting requirements, only the overall performance rate will appear on the profile pages of clinicians and groups in the Medicare.gov compare tool. All performance rate strata for these measures that meet testing requirements will be in the PDC.
